SUBJECT:	Lease to US House of Representatives for space at South Campus for Congressman Mike Thompson

RECOMMENDATION

Director of Public Works requests approval of and authorization for the Chairman to sign a lease agreement with the United States House of Representatives for a monthly charge of \$650 for the term January 3, 2017 through January 2, 2019 for office space located at 2721 Napa Valley Corporate Drive, Napa, California.

EXECUTIVE SUMMARY

The United States House of Representatives has requested the use of approximately 600 sq. ft. of space to provide office space for Congressman Mike Thompson at 2721 Napa Valley Corporate Drive (formerly known as South Campus Building 4). The lease term will begin on January 3, 2017 and expire on January 2, 2019 with a monthly rental fee of \$650 through the term of the lease.

BACKGROUND AND DISCUSSION

On February 10, 2015 County entered into Lease Agreement No. 8277 with the U.S. House of Representatives to provide 600 sq. ft. of space at County's South Campus Facility for Congressman Mike Thompson at a monthly cost of \$600 per month. This current lease will expire on January 2, 2017.

Today's request will provide for a new lease with the U.S. House of Representatives allowing Congressman Thompson continued use of the leased space as his district office for the term beginning on January 3, 2017 and expiring on January 2, 2019 with a monthly rental fee of \$650 through the term of the lease.
