**SUBJECT:** Agreement with Megabyte Systems, Inc. (previous A-4334 thru Amend. 15)

## **RECOMMENDATION**

Chief Information Officer requests approval of and authorization for the Chairman to sign an agreement with Megabyte Systems, Inc., for a maximum of \$322,364 for the term July 1, 2016 through June 30, 2017, with an automatic renewal at the end of each fiscal year, for maintenance and support services of the MPTS 2010+ Property Tax System.

### **EXECUTIVE SUMMARY**

Megabyte Systems, Inc. provides software support services required for the maintenance of the MPTS 2010+ Property Tax System. The total maintenance cost for Fiscal Year 2016-2017 is \$322,364, a 2.3% increase based on the San Francisco-Oakland-San Jose Consumer Price Index as permitted in the agreement.

This system was originally established in 1987 for Napa County's Assessor, Tax Collector and Auditor-Controller offices. The prior agreement with Megabyte, No. 4334, had been amended 15 times to adjust rates and reflect added functionality. For FY 2016-17, the County is entering into a new agreement with Megabyte to include the most up-to-date contract language.

Megabyte is not a local vendor.

#### **ENVIRONMENTAL IMPACT**

## **BACKGROUND AND DISCUSSION**

Megabyte is the developer of Megabyte Property Tax System (MPTS), a fully integrated, California property tax system. This system was originally established in 1987 and upgraded to a client server platform in 2000 for Napa County's Assessor, Tax Collector and Auditor-Controller offices. MPTS provides each of the departments with a set of processes necessary to perform property tax functions. For the Assessor, appraisal and personal property are a few of the core functions provided on the system. For the Auditor-Controller, direct assessments, redemption roll adjustments and tax rates are a few functions provided. For the Tax Collector, remittance processing, pay plans and delinquencies are a few of the many processes included within the system.

The previous Agreement No. 4334 had been amended 15 times to adjust rates and add functionality; in 2001: maintenance for Intranet and Internet added, in 2004: support for SQL database added, in 2008: support for online business property filing software added, in 2011: support for an upgraded system environment added. For Fiscal Year 2016-2017, the County is entering into a new agreement with Megabyte to include the most up-to-date contract language. The total maintenance cost for FY 2016-17 is \$322,364, a 2.3% increase from the prior year, based on San Francisco-Oakland-San Jose Consumer Price Index as permitted in the agreement.

Megabyte is not a local vendor. Megabyte currently provides integrated property system support to 27 counties throughout California. The system is designed specifically to meet California property tax requirements and provides a comprehensive integrated system encompassing Assessor, Auditor and Tax Collector.
