# RECOMMENDATION

Acting Director of Health and Human Services requests approval of Budget Transfer No. HHS002 appropriating \$141,855 in the Health Care Enhancement Programs budget with offsetting revenues from Medi-Cal Administrative Activities to fund contract expenditures. (4/5 vote required)

# EXECUTIVE SUMMARY

Approval of the requested action will increase the Health Care Enhancement Programs budget by \$141,855 to fund the delivery of Medi-Cal Administrative Activities (MAA) provided through the Community Based Organizations MAA program.

## **ENVIRONMENTAL IMPACT**

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

### BACKGROUND AND DISCUSSION

On September 24, 2013, the County's Health and Human Services Agency, the Local Government Agency (LGA), or the designated entity responsible for administering Medi-Cal Administrative Activities (AAA), launched a community-wide effort to outreach and enroll uninsured and potentially eligible residents in Medi-Cal coverage and to link them to needed health/behavioral health services. The essential component of this effort is subcontracting with qualified and interested Community Based Organizations (CBO) to perform Medi-Cal Administrative Activities (MAA). The CBO's are well regarded by the communities they serve and are very accessible to the target populations, making them the perfect vehicle to have positive proactive impact in reaching the uninsured.

Approval of the requested action will increase Health Care Enhancement Programs budget appropriations by \$141,855 to fund the delivery of MAA provided through the CBO MAA program, offset by increased MAA revenues of \$141,855.
