SUBJECT: Amendment No. 5 to Agreement No. 4708 with SimplexGrinnell

RECOMMENDATION

Director of Public Works requests approval of and authorization for the Chairman to sign Amendment No. 5 to Agreement No. 4708 with SimplexGrinnell, L.P., increasing the contract by \$12,578 for a new annual maximum of \$30,000, amending the scope of work to add fire sprinkler testing services at 3075 California Boulevard and to include a contract term end date.

EXECUTIVE SUMMARY

Approval of Amendment No. 5 to Agreement No. 4708 will allow for the inclusion of the 3075 California Boulevard Corporate yard, increase the maximum by \$12,578 for permit required testing and repairs, and will provide a term end date to the exising auto renew term of the contract. All other terms and conditions of the Agreement will remain the same.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

Fire Sprinkler preventive maintenance programs promote a safer environment in County facilities. Since 2002, SimplexGrinnell, L.P., under Napa County Agreement 4708 has provided fire sprinkler system maintenance for County Buildings. In December, 2012 the County purchased the Napa Corporate Yard, located at 3075 California Boulevard. Inclusion of 3075 California Boulevard in the Fire Sprinkler preventive maintenance program is necessary for compliance and a safe working environment.

Approval of this amendment increases the current maximum amount from \$17,422 to a new maximum of \$30,000 to allow for the inclusion of the corporate yard and any required testing or repairs at this or other county facilities maintained under this agreement. The Amendment will also provide a term end date to allow the County to compare and obtain competitive pricing for these services at the end of the term. All other terms and conditions of the Agreement will remain the same.
