## RECOMMENDATION

Human Resources Director requests adoption of a resolution amending the Table and Index in relation to the Public Health Division of the Health and Human Services agency effective December 4, 2007.

## EXECUTIVE SUMMARY

On October 16, 2007 the Board of Supervisors approved an agenda item creating the salary range for the new position of Emergency Medical Services Coordinating Manager. However, the salary range approved was incorrect. Approval of the requested action is necessary to correct the salary range.

The correct salary range for the given grade is \$5,588 - \$6,691 which represents a \$36.00 annual decrease in the salary for this position at Step 5. The proposed action corrects the salary to reflect a current range as listed in the management salary plan.
