SUBJECT: Climate Change

RECOMMENDATION

County Executive Officer and staff will provide a status report of ongoing activities regarding global climate change activities, invite Board comments and direction regarding future activities, and recommend the following actions:

- 1. Adoption of a resolution approving application for membership in the International Council for Local Environmental Initiatives (ICLEI) Local Governments for Sustainability Program; and
- 2. Authorization of payment of Fiscal Year 07-08 membership dues in the amount of \$1,200.

EXECUTIVE SUMMARY

Staff from Conservation, Development, and Planning, Public Works, Environmental Management, Public Health, and the Agriculture Commissioner together with representatives from NCTPA will present a summary of climate protection activities taking place in the County, including:

- Health effects of climate change;
- Statutory requirements and pending State legislation;
- Status report on the baseline analysis and action plan associated with County operations;
- Climate protection measures recommended in the proposed General Plan Update;
- Activities occurring in other areas:
- Discussion of the Cool Counties Initiative and:
- Recommendation to join the International Council for Local Environmental Initiatives (ICLEI) Local Governments for Sustainability Program.

Discretionary Justification: Joining ICLEI will assist the County to achieve sustainable development goals

(i.e. air quality, climate, water) through a step by step process of generating political awareness of key issues, establishing action plans toward defined, concrete, measurable targets, and meeting targets through project

implementation and evaluation. At the May NCTPA meeting, the Board of NCTPA unanimously passed a recommendation asking all member agencies

to:

1. Join the Cities for Climate Protection Program of ICLEI - Local Governments for Sustainability;

- 2. Join the "Energy Watch" Program of Association of Bay Area Governments (ABAG) and;
- 3. Sign the US Mayors Climate Protection Agreement.

To date, the City of St. Helena, City of Napa, and the Town of Yountville have taken all three actions. The Cities of Calistoga and American Canyon have had study sessions on the matter and further action is expected. The County has joined ABAG's Energy Watch.

Is the general fund affected? Yes

Future fiscal impact: Recommended budgets will include annual membership fees.

Consequences if not approved: The County will not be a member of ICLEI and will not benefit from the

collective experience of many other jurisdictions who are also working to

implement climate protection initiatives.

Over the past few years, there have been a number of initiatives, legislation and other activities regarding global climate change. Membership in this Program will allow the County to benefit from the collective experience of many other jurisdictions who are also working towards implementing climate protection measures.
