EXECUTIVE SUMMARY

County Executive Officer requests the appointment of one individual representing a community-based drug and alcohol treatment program to the Juvenile Justice Coordinating Council.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

There is currently one public member vacancy on the Juvenile Justice Coordinating Council (JJCC) due to a resignation. The County Executive Office has recruited for the opening and received two responses. Executive Director of Alternatives for Better Living William Ray Krimm and Wolfe Center Executive Director Thomas F. Powers are requesting appointment to the Council.

The Board of Supervisors adopted Resolution 01-02 on January 9, 2001 establishing the JJCC pursuant to Section 749.22 of the California Welfare and Institutions Code. There are sixteen (16) members of the JJCC, four of which are public members appointed by the Board of Supervisors. The purpose of the JJCC is as follows:

- a. To advise the Chief Probation Officer in the development of the proposed expenditure plan for funds provided under the Comprehensive Youth Services Act, and to advise the Chief Probation Officer with respect to compliance with all statutory state and federal guidelines and regulatory requirements;
- b. To develop and submit to the Board of Supervisors a Comprehensive Multi-agency Juvenile Justice Plan in accordance with the requirements of the Crime Prevention Act of 2000 and all guidelines and requirements of the State Board of Corrections; and,
- c. To develop methods of monitoring expenditure of funds, to insure quality of services provided, and to evaluate the outcome effectiveness of services and programs funded under the Comprehensive Youth Services Act (Chapter 3.2 of Part 6 of Division 9 of the Welfare and Institutions Code) and any other juvenile justice expenditures as the Board of Supervisors may direct.

Both applications were sent to the JJCC for review. At their October meeting the Council recommended Thomas F. Powers for appointment.
