## RECOMMENDATION

Director of Housing and Intergovernmental Affairs requests approval of and authorization for the Chair to sign Amendment No. 1 to Agreement No. 8181 with Arts Council Napa Valley (ACNV) increasing the amount by \$12,899 for a new maximum of \$44,493 for Fiscal Year 2014-15 for the purposes of hiring a consultant to give one or more workshops on grantwriting to Napa County arts and culture groups.

# EXECUTIVE SUMMARY

On April 25, 2012, the Board reserved twenty-five percent (25%) of the funds allocated in the Arts & Culture category of the Special Projects Fund for art-related projects/programs proposed by the Arts Council Napa Valley (ACNV) with the remaining amount reserved for projects/programs recommended by the Arts & Culture Advisory Committee to the Board. For FY 2014 - 15, ACNV submitted a grant request in the amount of \$31,594 to perform cultural marketing development and management; arts education development and outreach; public art development and outreach; advertising and marketing; website/online resources development; site visits/travel expenses; print communications and general and operating expenses.

On May 20, 2014 the Board approved the recommendations made by the Arts & Culture Advisory Committee ("Advisory Committee") to award grant to eleven non-profit organizations for a total of \$211,109 and a recommendation to have the remaining balance of \$12,899 be used to hire a consultant to give one or more workshops on capacity building and grant writing to Napa County arts and culture non-profits. This action will transfer that \$12,899 to ACNV for the purposes of hiring one or more consultants to give one or more workshops on capacity building and grant writing to Napa County arts and culture non-profits.
