SUBJECT: Amendment No. 1 to Agreement with Community Impact Consulting, Inc.

RECOMMENDATION

County Executive Officer requests approval of and authorization for the Chair to sign Amendment No. 1 to Agreement No. 6157 with Community Impact Consulting, Inc. increasing the amount by \$8,000 for a new maximum of \$58,000 and revising the scope of work to include grant writing services related to the development of the proposed South Napa Homeless Shelter.

EXECUTIVE SUMMARY

Community Impact Consulting, Inc. provides consultation to the County regarding Tobacco Settlement Funds, the proposed South Napa Homeless Shelter and Transitional Housing Projects, and the Safety Net Food System. This amendment provides additional funds for grant writing services related to the development of the South Napa Homeless Shelter.

ENVIRONMENTAL IMPACT

BACKGROUND AND DISCUSSION

On March 12, 2002, the Board approved an agreement with Terry Longoria to provide consultation to the County which initially involved various aspects of indigent care and assistance with recommendations regarding the distribution of Tobacco settlement funds. Since the original agreement Ms. Longoria has joined Community Impact Consulting, Inc. and services have been expanded to include consultation in connection with the proposed relocation of the homeless shelter to a site provided by the Gasser Foundation and monitoring of the Safety Net Food System in the county. Ms. Longoria has been working with community representatives as well as government agencies to facilitate and assist with the proposed homeless shelter including working with Home Base and others in the successful award of a \$1,000,000 forgivable loan for the construction of a homeless shelter.

The proposed action before you today will increase the Community Impact Consulting, Inc. Agreement to increase the contract maximum by \$8,000 for the provision of grant writing services related to the development of the proposed homeless shelter.
