# **RECOMMENDATION**

Human Resources Director requests adoption of a resolution amending the Departmental Allocation List for Information Technology Services Division of the County Executive Office with regards to deleting one (1) Computer Systems Coordinator and one (1) Information Systems Specialist I/II/Senior and adding two (2) Information Systems Supervisor positions, effective February 7, 2006.

## **EXECUTIVE SUMMARY**

The Chief Information Officer, in conjunction with an outside organizational consultant, has undertaken a study to identify needed organizational changes in the Information Technology Services Division which will facilitate increased productivity, enhance customer service, and provide more consistent direction to the staff. One of the changes that has been identified is the need for additional supervisors to provide the daily technical and administrative direction in order to free more time for the Information Systems Managers to develop and implement action plans to ensure that operational goals are met.
