SUBJECT:	Amendments to Agreements with Boys and Girls Club and COPE Family Center

## RECOMMENDATION

Director of Health and Human Services requests approval of and authorization for the Chair to sign the following amendments regarding the Safe and Drug Free Schools and Communities Grant:

- Amendment No. 1 to Agreement No. 6255 with COPE Family Center, incorporating agency-wide changes to the General Terms and Conditions, revising the scope of work to include new principal objectives, revising the budget for the current grant year, and increasing the amount by \$22,112 for a new maximum of \$111,753; and
- 2. Amendment No. 2 to Agreement No. 6254 with the Boys and Girls Club of Napa Valley, revising the budget for the current grant year.

## EXECUTIVE SUMMARY

Napa County received a grant from the State Department of Alcohol and Drug Programs to provide youth skills training and environmental prevention services under the Safe and Drug Free Schools and Communities Grant.

COPE Family Center provides provide home visitation and parent education services to families of youth ages 10-14. The amendment incorporates agency-wide changes to the General Terms and Conditions, revises the scope of work to include new principal objectives of the program and increases the maximum amount to fund the full grant period through August 31, 2005.

The Boys and Girls Club facilitates skill development groups and a community service youth club for youth ages 10-14. The amendment revises the budget to fund the full grant period through August 31, 2005.

Discretionary Justification:	These contracts are fully funded by categorical alcohol and drug funds received by Napa County from the State Department of Alcohol and Drug Programs for the Safe and Drug Free Schools and Communities Grant. These agreements have no general fund impact.
Is the general fund affected?	No
Future fiscal impact:	Although the agreements terminate August 31, 2005, they contain an automatic renewal provision, which allows the county the option to continue these services in the following fiscal year.
Consequences if not approved:	The county will not be able to claim the full Safe and Drug Free Schools grant award.

## ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

## BACKGROUND AND DISCUSSION

Under the COPE agreement, home visitors assist families in accessing resources and developing parenting skills to improve family functioning. Services are provided in English and Spanish. In addition, COPE provides a six-week parent education curriculum (in Spanish and English) that assists families in developing communication skills, builds family cohesion and assists parents in guiding their children through the challenges of adolescence. Target families include families of youth in prevention programs, families in substance abuse treatment with children 10-14, and families with children 10-14 who are receiving mental health services. The original agreement covered the period February 1, 2004 through August 31, 2004 and contained an automatic renewal provision that extended that agreement though August 31, 2005. The amendment revises the scope of work to include new principal objectives and timelines for the continuation of services for the program year and increases maximum amount of the agreement to reflect a full year of grant funding.

The Boys and Girls Club facilitates skill development groups using the SMART Moves program for youth ages 10-14. The SMART Moves program is an eight-week curriculum that covers a range of life skill development areas such as communication skills, decision-making, conflict management, and drugs and alcohol. Upon completion of the curriculum, participants "graduate" into Torch Club, a service club for middle school youth. Through their participation in Torch Club, youth are involved in community service projects that address environmental alcohol and tobacco issues that are of concern to youth such as binge drinking, youth access to alcohol and tobacco, and media. The original agreement covered the period February 1, 2004 through August 31, 2004 and contained an automatic renewal provision that extended that agreement though August 31, 2005. The amendment revises the budget within the same total amount. COPE Family Center and the Boys and Girls Club of Napa Valley are not health care providers for purposes of HIPAA. This position was taken because there is no use or disclosure of protected health information by or to the vendors under these agreements.
