BACKGROUND AND DISCUSSION

The Napa County Commission on Aging currently has one vacancy representing an organization concerned with older adults. The County Executive Office has recruited for the opening and received three completed applications.

The Napa County Commission on Aging was created pursuant to Resolution No. 77-151 adopted September 13, 1977. It consists of 13 members, five members (5) represent each Supervisorial District and eight (8) members are recommended by organizations concerned with older adults.

The purpose of the Commission is as follows:

- | To assess existing data to identify the presently unmet needs of older adults within the County and to describe alternative methods by which such needs might be met;
- | To recommend the initiation of studies or programs oriented to older adults; however, such studies or programs as may be initiated by the County shall not be directly administered by the Commission except with the prior approval and direction of the Board of Supervisors;
- | To act as an advisory body on behalf of the Board of Supervisors in the studying, evaluating and recommending "grant" and program proposals affecting the well-being of older adults in the County (The Board of Supervisors anticipated that priority would be given to those activities which promote the independence and dignity of individuals and which are directed toward the elimination of any discrimination based upon age.);
- | To review and offer comment upon pending legislation; and,
- | To disseminate information to older adults concerning the availability of various activities and services provided within the County on behalf of the elderly.

The Nominating Committee of the Commission on Aging recommends the appointment of Mary Anna Imbelloni.
