SUBJECT: Approval of amendments to Professional Services Agreement No. 4793

## **RECOMMENDATION**

County Counsel requests approval of and authorization for the Chairman to sign Amendment No. 6 to Agreement No. 4793 with John Dawdy increasing the maximum amount by \$41,000 for a new maximum of \$55,000 for the term of January 15, 2016 through June 30, 2016 and revising the scope of work to include hearings held at St. Helena Hospital.

#### **EXECUTIVE SUMMARY**

A certification hearing is held to determine whether an individual who has been detained in a mental health facility and found to be a danger to self or others continues to require further mental health treatment and evaluation. The County has contracted with John Dawdy and Judith Jones to provide services as hearing officers for Welfare and Institution Code 5250 certification review hearings for individuals at Napa State and St. Helena Hospitals, the County's designated Welfare and Institutions Code 5150 facilities. Judith Jones' contract as the County's hearing officer at St. Helena Hospital was terminated effective January 15, 2016. County wishes to amend its contract with John Dawdy, who will take over responsibility for hearings at St. Helena Hospital.

Is it Mandatory or Discretionary? Discretionary Discretionary Justification: The IRS rate is intended to reimburse for the per mile cost of normal

for the contractor to be reimbursed at that rate.

#### **ENVIRONMENTAL IMPACT**

## BACKGROUND AND DISCUSSION

A certification hearing is held to determine whether an individual who has been detained in a mental health facility and found to be a danger to self or others continues to require further mental health treatment and evaluation. Certification review hearing officers must be unanimously approved by the County Public Defender, Mental Health Director and County Counsel. John Dawdy have been unanimously approved and have provided these services to the County since 2001.

Staff seeks approval of a contract amendment to John Dawdy's contract to perform certification review hearings at both Napa State Hospital and St. Helena Hospital from January 16, 2016 forward. Judith Jones ceased to conduct hearings at St Helena Hospital on January 15. Effective January 16, 2016, all hearings will be conducted by John Dawdy or, in his absence, by an alternative hearing officer provided and paid by Mr. Dawdy.
