# RECOMMENDATION

County Executive Officer requests authorization for out of state travel for Diane Dillon, Supervisor District Three, who traveled to Washington, D.C., to conduct legislative and administrative advocacy from February 28-March 6, 2007.

### EXECUTIVE SUMMARY

County Executive Officer (CEO) requests approval of out of state travel for Diane Dillon, Supervisor District Three, who traveled to Washington, D.C. from February 28-March 6, 2007 to conduct legislative and regulatory advocacy with members of Congress and the Interior Department/Bureau of Indian Affairs on the subject of reservation shopping and related tribal matters and administrative advocacy related to the Bureau of Reclamations' visitor service plan for Lake Berryessa. Estimated cost of this travel is \$2,400.

# ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

### BACKGROUND AND DISCUSSION

County Executive Officer (CEO) requests after-the-fact approval for out of state travel for Diane Dillon, Supervisor District Three, who traveled to Washington, D.C. from February 28-March 6, 2007. The primary purpose of Supervisor Dillon's trip was to participate in legislative and regulatory advocacy meetings with other members of the Northern California Counties Tribal Matters Consortium (Napa, Solano, and Sonoma Counties) with the objective of communicating the consortium's concerns about reservation shopping and related tribal matters to members of Congress and the Interior Department/Bureau of Indian Affairs. Supervisor Dillon also conducted administrative advocacy at the Bureau of Reclamation and the Department of the Interior concerning the Lake Berryessa visitor service plan.

The County's transportation and travel policy requires all out of state travel by the CEO, elected officials, and members of the Board of Supervisors receive prior approval from the Board of Supervisors. However, in circumstances where it is not possible to receive prior approval, the CEO may authorize out of state travel for elected officials subject to after-the-fact ratification by the Board of Supervisors.

In this case, the Northern California Tribal Matters Consortium had planned this advocacy trip for some time and originally Supervisor Wagenknecht had planned to represent Napa County. However, due to scheduling changes Supervisor Wagenknecht did not attend and Supervisor Dillon attended as the County representative.
