## RECOMMENDATION

Director of Public Works requests acceptance of the work as complete and authorization for the Chair to sign and Clerk of the Board to file a Notice of Completion with the Clerk/Recorder for Contract No. PW 04-19, "Hall of Justice Planning Remodel Project."

#### **EXECUTIVE SUMMARY**

On December 7, 2004 the Board awarded the contract, "Hall of Justice Planning Remodel Project," PW 04-19 to Murray Building in the amount of \$33,905. Work is complete and staff requests approval to file Notice of Completion.

Additional Information:

The contract amount was \$33,905 and a change order for additional work was issued in the amount of \$2,656 for a total construction cost of \$36,561. The budget for this project was \$45,000 which covered design, in-house project management, construction, and administration costs.

#### **ENVIRONMENTAL IMPACT**

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

## **BACKGROUND AND DISCUSSION**

The Planning Department needed to reconfigure a portion of the Conservation Division's space within the Hall of Justice to control public access to staff areas, minimize worker disruption from the public, and provide an ADA compliant counter for public use.

To control public access, the main counter had to be located so that access would be from outside their area. This was done by combining a closet just outside the main access door with an office. The wall between the two rooms was partially removed and a new custom counter/workstation was constructed with a lift top counter which doubles as a handicap accessible counter. The main doorway into the Conservation Department had a keypad lock added for restricted access. This door is also controlled with a push button located at the new counter. The new interior space was painted to complete the new reception area. New ADA compliant door opener was added to new main entrance door.
