SUBJECT: Agreements with MedMark Treatment Center-Fairfield, Inc. and Successful Alternatives for Addiction Counseling Services, Inc.

RECOMMENDATION

Director of Health and Human Services requests approval of and authorization for the Chair to sign the following agreements for the provision of outpatient medication-assisted treatment for opioid addiction, each for the term April 23, 2019 through June 30, 2020, and each with a provision for annual renewal:

1. Agreement with MedMark Treatment Centers-Fairfield, Inc., for a maximum of \$94,900; and
2. Agreement with Successful Alternatives for Addiction Counseling Services, Inc. for a maximum of \$270,100.

EXECUTIVE SUMMARY

MedMark Treatment Centers-Fairfield and Successful Alternatives for Addiction Counseling Services, provide outpatient medication-assisted treatment for opioid addiction utilizing methadone and buprenorphine. Both programs provide evidence-based treatment that is supported by substance abuse counseling, case management, community resource referrals and other supportive services.

Approval of today's action will enable the contractors to provide methadone, buprenorphine, disulfiram and naloxone treatment services to specifically referred clients of County's Alcohol and Drug Services program. These contracts will bring the services within the Organized Delivery System, as required under the master agreement between the County and the State Department of Health Care Services.

MedMark Treatment Centers and Successful Alternatives for Addition Counseling Services are not local providers. There are no local vendors in Napa that provide this type of service.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

The County, through the Alcohol and Drug Services Division of the Health and Human Services Agency, has undertaken to reconfigure the services for substance use disorders provided to County residents covered by Medi-Cal and other low income county residents into an "Organized Delivery System." This is a managed care model comprising a range of coordinated services, as specified in the County's contract with the California Department of Health Care Services dated December 15, 2017 (Napa County Agreement No. 180182B). The contracts being submitted here for Board consideration cover state-mandated "narcotic treatment" services provided to Napa County residents. Both providers are located in Solano County and are the closest and most accessible programs for Napa County residents, as there are no programs providing these services located in Napa County. The providers hold the necessary state authorizations to conduct these services and have been providing them to Napa County residents for a number of years. These contracts will bring the services within the Organized Delivery System, as required under the master agreement between the County and the State Department of Health Care Services.

MedMark Treatment Services-Fairfield and Successful Alternatives for Addiction Counseling Services are not local vendors.
