| SUBJECT:          | Amend the Departmental Allocation List - HHSA Substance Abuse Services Division |

## **RECOMMENDATION**

Director of Health and Human Services and the Human Resources Director request adoption of a resolution amending the Departmental Allocation List for the Substance Abuse Services Division of Health and Human Services Agency as follows, effective April 24, 2007:

- 1. Delete one (1) .5 FTE Mental Health Counselor; and
- 2. Add one (1) Health Education Specialist

## EXECUTIVE SUMMARY

Approval of the requested actions will enable HHSA's Substance Abuse Services Division to collaboratively team with the Agency's Mental Health Division to implement the co-occurring disorders treatment project under the Mental Health Services Act (Prop. 63). The addition of a net 0.5 FTE, funded by new MHSA funds, will enable the conversion of an existing, vacant 0.5 FTE Mental Health Counselor to a 1.0 FTE Substance Abuse Services Health Education Specialist. The expected impact of the action will be to increase the ability of HHSA to communicate information to the community regarding both, Alcohol and Drug Prevention and the Mental Health Services Act programs.

## ENVIRONMENTAL IMPACT

## BACKGROUND AND DISCUSSION

Funding recently made available by the Mental Health Services Act - Prop. 63 (MHSA) is presenting Napa County Health and Human Services Agency with the opportunity to develop and implement additional, evidence-based prevention and early intervention programming through the Prevention and Early Intervention phase of the statewide MHSA initiative. This phase is planned to begin in August 2007. Developing and implementing prevention programming is a relatively new undertaking in the field of mental health, but one that can benefit from the experience and expertise of the Substance Abuse Division that has been developing evidence-based prevention programs in Napa County for a number of years. Thus, HHSA's Mental Health Division and Substance Abuse Division are planning to collaborate in the implementation of this new MHSA phase.

To this end, HHSA proposes the addition of a net 0.5 FTE, by adding a 1.0 FTE Health Education Specialist position, funded through Substance Abuse Prevention Block Grant Funds (50%) and Mental Health Services Act

Expansion Funds (50%), and deleting an existing, vacant 0.5 FTE Mental Health Counselor position. The Health Education Specialist position will be responsible for data collection; coordinating training; identifying funding for sustainability or expansion; gathering and disseminating best practice information; and reporting outcomes to internal and external stakeholders.
