RECOMMENDATION

Registrar of Voters requests approval of and authorization for the Chairman to sign a letter requesting extension of the term of Amendment No. 3 to Agreement No. 6017 with Dominion Voting Systems, Inc. through June 30, 2016 with all other terms to remain the same.

EXECUTIVE SUMMARY

The Registrar of Voters contracts with Dominion Voting Systems, Inc. to provide ballot design, electronic voting equipment and ballot reader maintenance support, ballot tabulation software and technical support under Agreement No. 6017. The current amended agreement adopted April 24, 2012 which expires June 30, 2014 provides that the term of the agreement can be extended until June 30, 2016 at the request of the County. There have been no changes in the Support and Service fees during the current term and no changes are proposed during the two year extension.

A letter requesting the two year extension has been prepared and approved by County Counsel for the Board Chairman to sign.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

The Registrar of Voters contracts with Dominion Voting Systems, Inc. to provide ballot design, electronic voting equipment and ballot reader maintenance support, ballot tabulation software and technical support under Agreement No. 6017. Napa County is over 85% vote by mail and the Dominion 400C ballot reader and tabulator is vital to producing timely and accurate election results. This voting system constitutes the most current technology certified by the California Secretary of State.

The current amended agreement adopted April 24, 2012 which expires June 30, 2014 provides that the term of the agreement can be extended until June 30, 2016 at the request of the County. There have been no changes in the Support and Service fees during the current term and no changes are proposed during the two year extension.

A letter requesting the two year extension has been prepared and approved by County Counsel for the Board Chairman to sign.
