SUBJECT:	Transfer from Contingencies to Conflict Public Defender Budget

## RECOMMENDATION

County Counsel requests approval of Budget Transfer No. 59 appropriating \$170,000 in the Conflict Public Defender budget and reducing the General Fund Contingencies by an equivalent amount, to cover attorney fees and other costs related to indigent defense. (4/5 vote required)

## **EXECUTIVE SUMMARY**

The Conflict Public Defender budget has paid \$726,456 to date for indigent defense services. Of this amount, \$253,800 has been paid to the County's Level I and II conflict contractors, \$215,070 to court-appointed attorneys, and \$257,586 for investigation, experts and other specialized legal costs. It is projected that an additional \$170,000 will be needed to cover the increase in investigative and court-appointed attorney services related to caseload increases as well as an increase in the number of hours billed.

The legal and investigative costs for future fiscal years is unknown since the costs are caseload driven. The projected costs for fiscal year 07/08 will be the same as Fiscal Year 06/07. The County Executive Office is currently reviewing an alternative conflict public defender program which, if approved by the Board

	of Supervisors, will become effective July 1, 2007 and should reduce overall costs. Thus, our usual approach, projecting a slight increase in costs year over year, has been abandoned for Fiscal Year 07/08.
Consequences if not approved:	The Conflict Public Defender budget will be unable to pay claims from investigators, experts and attorneys for their services as appointed by the Napa Superior Court.

### ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

#### BACKGROUND AND DISCUSSION

The Conflict Public Defender budget has paid \$726,456 to date for indigent defense services. Of this amount, \$253,800 has been paid to the County's Level I and II conflict contractors, \$215,070 to court-appointed attorneys, and \$257,586 for investigation, experts and other specialized legal costs. This increase in services is due to an increase in the following types of cases that have exceeded to a significant degree the average number of such cases in prior years: domestic violence, driving under the influence, juvenile delinquency, sexual assault and sexually violent predators. For example, in Fiscal Year 2005-06 (July-March) there were 29 court-appointed juvenile cases for a total of \$12,235. However, in Fiscal Year 2006-2007 (July-March) there were 64 juvenile cases for a total of \$49,279.

It is projected that an additional \$170,000 will be needed in addition to the budgeted \$855,464 to cover the increase in investigative and court-appointed attorney services related to caseload increases as well as an increase in the number of hours billed.
