SUBJECT: Illumination Technologies proposes to install 32 Poles for sirens and telecommunication

equipments

RECOMMENDATION

Director of Public Works requests the Board to hear and provide staff direction on a proposal by Illumination Technologies to install 32, approximately 50 foot tall, monopoles for sirens and telecommunications equipment.

EXECUTIVE SUMMARY

Illumination Technologies and Chris Canning are to provide a presentation to the Board on their potential proposal to install 32 monopoles, each approximately 50 foot tall, at various locations on the County's right-of-way, to house fire sirens and telecommunication equipments. The poles will be substantially similar to the pole already installed on Rosedale Road (picture and schematic drawings are attached). Following the presentation, staff will provide input on our current ordinances, processes, and procedures for handling a typical encroachment permit application, and seek direction from the Board as to whether changes are required.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable. Any changes to ordinances, processes, or procedures requested by the Board would be subject to CEQA review.

BACKGROUND AND DISCUSSION

Following the fires of 2017, Chris Canning requested an encroachment for space in the public right of way to install two fire sirens which would be used to warn residents in the event of a fire. One siren was planned for Rosedale Road, and another for Petrified Forest Road. Ministerial permits were issues and two, 50 foot monopoles were installed. A picture of the pole on Rosedale Road and a schematic drawing of the pole are attached for information.

Illumination Technologies and Chris Canning have verbally discussed installing 32 additional poles, which will also include telecommunications equipments. They have been invited here today to provide a presentation to the Board on details of their proposal. As staff has not yet seen this proposal, we are unable to comment on it specifically here, but it is presumed that the poles will be substantially similar to the pole already installed on Rosedale Road. Following the presentation, staff will provide input on our current ordinances, processes, and procedures for handling a typical encroachment permit application, and seek direction from the Board as to whether changes are required for this type of proposal.

County Counsel will also be present to discuss any limitations the county may have given telecommunications and right of way law.
