SUBJECT: Amendment No. 1 to Agreement No. 7152-1 with Carrie Hays, dba The Halle Group

RECOMMENDATION

Director of Human Resources requests approval of and authorization for the Chairman to sign Amendment No. 1 to Agreement No. 7152-1 effective February 1, 2014 with Carrie Hays, doing business as The Halle Group, increasing the amount of the contract by \$30,000 for a new maximum of \$78,000 and amending the scope of work to include additional training opportunities for County employees.

EXECUTIVE SUMMARY

The County has been contracting with Carrie Hays since 2005 to develop program materials and training for County employees. During FY 2013-14 she has expanded her services to include strategic planning as well as the continuing to offer customized consulting, coaching, and organizational development facilitation services for County departments. Ms. Hays has been providing these additional services since February however due to workload issues, the contract amendment was not completed.

Ms. Hays is a local vendor.

BACKGROUND AND DISCUSSION

The County has been contracting with Carrie Hays since 2005 to develop program materials and training for County employees. Carrie Hays has been providing customized consulting, coaching, and facilitation services for County departments. Director of Human Resources requests approval of and authorization for the Chair to sign an amendment to the agreement with Carrie Hays, doing business as The Halle Group, for a maximum of \$78,000 for professional services for services provided to County employees. In FY 2014-15, management of this contract will be provided by the Training and Organizational Development Division of the County Executive Officer. This will help to assure that all training and development opportunities across departments is done consistently utilizing Board approved policies.
