SUBJECT: Amendments to Agreements with Loyd Wolfe Juvenile Justice Network (Drug Medi-Cal & Youth Treatment)

RECOMMENDATION

Director of Health and Human Services requests approval of and authorization for the Chairman to sign the following amendments with Loyd Wolfe Juvenile Justice Network, Inc., each incorporating Addenda to the Scope of Work and Compensation sections to include additional reporting and confidentiality requirements for the provision of substance abuse treatment services for youth who are clients of the County's alcohol and drug program:

1. Amendment No. 7 to Agreement No. 6605; and
2. Amendment No. 1 to Agreement No. 7511.

EXECUTIVE SUMMARY

Loyd Wolfe Juvenile Justice Network provides substance abuse treatment services to youth who are clients of the County's alcohol and drug program. The services include individual and family counseling, treatment planning, collateral services; discharge planning, crisis intervention and group counseling. Approval of the recommended amendments will incorporate Addenda to the Scope of Work and Compensation sections in each agreement to include Language Access Services Standards of the National Standards on Culturally and Linguistically Appropriate Services (CLAS) published by the Office of Minority Health and changes to standardize the language regarding quarterly contract provider meetings, reporting requirements and confidentiality.

Loyd Wolfe Juvenile Justice Network is a local vendor.

ENVIRONMENTAL IMPACT

BACKGROUND AND DISCUSSION

Loyd Wolfe Juvenile Justice Network, Inc. (Wolfe Center) is a substance abuse treatment program for youth in the community. The Contractor is certified as a substance abuse treatment clinic by the State Department of Alcohol and Drug Programs (ADP) and also operates certified satellite and clinic treatment facilities throughout Napa County.

Agreement No. 7511:

Under this agreement, Wolfe Center provides Drug Medi-Cal billable substance abuse treatment services to youth ages 10-18 years old who are clients of the County's alcohol and drug program. The services include individual and family counseling, treatment planning, collateral services, discharge planning, crisis intervention and group counseling.

Agreement No. 6605:

Under this agreement, Wolfe Center provides early intervention services (brief intervention and brief treatment services) in school and community settings. Wolfe also provides outpatient treatment intake and assessment, individual and group services, family education and counseling and other services including random drug testing and aftercare. Psychiatric assessment services are also available. This agreement provides for reimbursement of treatment services provided to youth ages 12-18. Services are provided at the Wolfe Center's main site in Napa, as well as satellite locations around the County.

Approval of the recommended amendments will incorporate Addenda to the Scope of Work and Compensation sections in each agreement to include Language Access Services Standards of the National Standards on Culturally and Linguistically Appropriate Services (CLAS) published by the Office of Minority Health and changes to standardize the language regarding quarterly contract provider meetings, reporting requirements and confidentiality. There is no change to the maximum amount of each agreement, the maximum amounts will remain the same.
