SUBJECT: Amendment No. 4 to Agreement No. 3370 with R.A. Bridgeford, Inc.

RECOMMENDATION

Director of Public Works/Aviation requests approval of and authorization for the Chair to sign Amendment No. 4 to revenue Agreement No. 3370 with R.A. Bridgeford, Inc. extending the term through June 30, 2006 for retail aviation fuel services.

EXECUTIVE SUMMARY

Fuel Management Agreement No 3370, with the County's "Fuel Manager" R.A. Bridgeford, dba Bridgeford Flying Services (BFS), expires May 31, 2006. The County and BFS are in the process of finalizing the terms and conditions of a new agreement, and anticipate having this agreement ready for approval by the Board of Supervisors during June, 2006. A final one month extension is being requested to provide time to finalize this new agreement.

BACKGROUND AND DISCUSSION

Fuel Management Agreement No. 3370, with the County's "Fuel Manager" R. A. Bridgeford, dba Bridgeford Flying Services (BFS), expired May 31, 2005. Amendment No. 3 was approved on November 15, 2005 to provide time to work with BFS as recommended by the Airport Advisory Commission to develop a new agreement as warranted with repayment of the 1990 Certificates of Participation. Staff anticipates having a new agreement ready for presentation to the Board of Supervisors during June, 2006. A final one month extension is being requested to provide time to finalize this new agreement, and allow the present retail aviation fuel services to be provided without interruption to the airport's clients.
