SUBJECT: Lease Agreement with Tuteur Trust at 1917 First Street

RECOMMENDATION

Director of Public Works requests approval of and authorization for the Chair to sign a Lease Agreement with Waltraud and John Tuteur 1989 Revocable Family Trust for space located at 1917 First Street, Napa, for a maximum of \$32,880 annually for a five year term beginning July 1, 2005 through June 30, 2010 for Health and Human Services Village Project.

EXECUTIVE SUMMARY

Napa County has leased 1917 First Street for use by Health and Human Services since 1986. Health and Human Services operated an adult program called Community House at this location until the end of 2004.

At this time, Health and Human Services wishes to continue leasing the building which will house the Village Project. This project is a wrap around project for children who would otherwise be in high level residential programs. The program is a combined effort by Child Welfare Services, Probation and Mental Health.

ENVIRONMENTAL IMPACT

BACKGROUND AND DISCUSSION

Napa County has leased 1917 First Street for Health and Human Services since 1986. Health and Human Services operated an adult program called Community House at this location until the end of 2004.

At this time, Health and Human Services wishes to continue leasing the building to house the Village Project. This project is a wraparound project for children who would otherwise be in high level residential programs. The program is a combined effort by Welfare, Probation and Mental Health.

Funding comes from the SB 163 wraparound program designed to keep kids out of group homes. It allows the County to set up a trust fund from monies that would have been used for group home placements and instead use the funds to provide a variety of intensive services designed to keep the participants out of group homes. There are adequate funds to pay the space costs indefinitely.
