The agenda is divided into three sections:

CONSENT ITEMS - These matters typically include routine financial or administrative actions, as well as final adoption of ordinances that cannot be both introduced and adopted at the same meeting. Any item on the CONSENT CALENDAR will be discussed separately at the request of any person. CONSENT CALENDAR items are usually approved with a single motion.

SET MATTERS - PUBLIC HEARINGS - These items are noticed hearings, work sessions, and items with a previously set time.

ADMINISTRATIVE ITEMS - These items include significant policy and administrative actions and are classified by program areas. Immediately after approval of the CONSENT CALENDAR, if the time for hearing SET MATTERS has not arrived, ADMINISTRATIVE ITEMS will be considered.

Human Services

A. Director of Health and Human Services requests approval of and authorization for the Chairman to sign the renewal of Agreement No. 7490 with Project Ninety, Inc., for a maximum of \$11,850 for the term May 3, 2011 through September 30, 2011 to provide short-term alcohol and drug residential treatment services.

Community Resources & Infrastructure

- **B.** Director of Conservation, Development and Planning and County Executive Officer request the following related to the Health and Human Services Agency (HHSA) campus redevelopment project:
 - Approval of and authorization for the Chairman to sign an agreement with LSA Associates for a maximum of \$283,540 for the term May 3, 2011 through June 30, 2011 with a provision for automatic renewal for one additional year for the preparation of an Environmental Impact Report; and
 - Approval of Budget Transfer No. CEO018 increasing appropriations by \$400,000 in the HHSA Construction budget with an offsetting increase in appropriations and cancelation of a designation in the amount of \$400,000 in the Accumulated Capital Outlay Fund. (4/5 vote required)
