SUBJECT:	Ratify the Acceptance of a Donation From Hub City Terminals, Inc.

## **RECOMMENDATION**

Sheriff requests approval of the following actions related to the donation of a 53 foot refrigerated trailer to the Coroner's Office from Hub City Terminals, Inc. (4/5 vote required):

- 1. Ratify the acceptance of the donation;
- 2. Establish a capital asset in the amount of \$12,000 for the refrigerated trailer; and
- 3. Approval of Budget Transfer No. SHE002, increasing appropriations in the Sheriff-Coroner's budget with offsetting revenues in the amount of \$12,000 to recognize the value of the donation.

### **EXECUTIVE SUMMARY**

In accordance with Board Resolution No. 05-40 and the Recommended Procedure for the Acceptance and Disbursements of Gifts, Bequests, or Devices in excess of \$1,000.

On April 7, 2020 the Board adopted Resolution No. 2020-47 delegating authority to the County Executive Officer / Director of Emergency Services or designee to accept donations of any kind to assist with the response to COVID-19. Due to the timing and specific purpose of the donation, the Sheriff's Office, with the approval of the County Executive Officer and Director of Emergency Services, accepted the donation of the refrigeration trailer to be placed at Respite Cove. This agenda item has been prepared: to ratify the acceptance of the donation from Hub City Terminals, Inc., to establish the capital asset in the amount of \$12,000, and to approve the budget transfer to recognize and record the monetary value of the trailer.

### ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

#### BACKGROUND AND DISCUSSION

On April 2, 2020, the Sheriff-Coroner's Office, with the approval of the County Executive Officer and Director of Emergency Services, accepted the donation of a 53-foot 2004 Wabash refrigerated trailer from Hub City Terminals, Inc. The refrigerated trailer will be used to increase the Sheriff-Coroner's Office storage capacity for decedents during the COVID-19 event, natural disasters, pandemics, or other mass casualty occurrences.

In accordance with Board Resolution 05-40 and the Recommended Procedure for the Acceptance and Disbursement of Gifts, Bequests, or Devices in excess of \$1,000, this agenda item has been prepared to ratify the acceptance of the refrigerated trailer valued at \$12,000. In addition, the Sheriff requests approval to establish the refrigerated trailer as a capital asset and approval of a budget transfer to establish appropriation authority for the capital asset offset with the donation value.
