SUBJECT: Amendment No. 1 to agreement with Crestwood Behavioral Health, Inc.

RECOMMENDATION

Director of Health and Human Services requests approval of and authorization for the Chair to sign Amendment No. 1 to Agreement No. 8144 with Crestwood Behavioral Health, Inc., modifying Section 1.7-Contract Administration, incorporating Specific Terms and Conditions 3.1(a) Contract with Vulnerable Population such as Children, Elderly, Mentally Ill or Disabled Persons; incorporating Specific Terms and Conditions 3.1(d) Services Covered by a Federal Health Care Program; incorporating Specific Terms and Conditions 3.1(e) Services Covered by a State Specialty Mental Health Program; incorporating Addenda to the Scope of Work and Compensation sections to include a revised billing structure for the provision of acute psychiatric inpatient services.

EXECUTIVE SUMMARY

On May 1, 2014, the Board approved a new agreement with Crestwood Behavioral Health to provide long-term, inpatient mental health treatment, which includes skilled nursing services, psychosocial rehabilitation services, behavior management, life skills training, and geropsychiatric services. Approval of the recommended agreement will:

- | modify Specific Terms and Conditions, Section 1.7-Contract Administration;
- | incorporate Specific Terms and Conditions 3.1(a) Contact with Vulnerable Population such as Children, Elderly, Mentally Ill or Disabled Persons;
- | incorporate Specific Terms and Conditions 3.1(d) Services Covered by a Federal Health Care Program;
- | incorporate Specific Terms and Conditions 3.1(e) Services Covered by a State Specialty Mental Health Program; and
- | incorporate Addenda to the Scope of Work and the Compensation section to include revised billing structure for the provision of acute psychiatric inpatient services.

Approval of this action will enable the County to bill Medi-Cal for these services.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

Crestwood Behavioral Health, through its Solano Psychiatric Health Facility (PHF), is a 16 bed mental health stabilization program located at 2201 Tuolumne Street in Vallejo, California. The PHF provides a secure structured program for individuals experiencing a psychiatric crisis requiring 24-hour observation and stabilization by a team of professional staff. The facility admits individuals 18 years of age or older who may be admitted on either a voluntary or involuntary basis. The PHF provides an alternative to traditional psychiatric care and stabilization for residents of Napa County experiencing an acute psychiatric emergency of such magnitude that it is unmanageable in the community. The Mental Health Division is contracting for two dedicated beds and the agreement includes provisions that will allow the Mental Health Division to sell a portion of its bed days to and to utilize a courtesy bed from another participating County or entity.

Approval of the recommended agreement will:

- | incorporate Specific Terms and Conditions 3.1(a) Contact with Vulnerable Population such as Children, Elderly, Mentally Ill or Disabled Persons;
- | incorporate Specific Terms and Conditions 3.1(d) Services Covered by a Federal Health Care Program;
- | incorporate Specific Terms and Conditions 3.1(e) Services Covered by a State Specialty Mental Health Program; and
- | incorporate Addenda to the Scope of Work and the Compensation section to include revised billing structure for the provision of acute psychiatric inpatient services.

Approval of this action will enable the County to bill Medi-Cal for these services. There is no change to the maximum dollar amount of the agreement, the revised billing structure increases will be absorbed within the existing annual contract maximum of \$662,650.
