Recommended Final Budget Hearings for Fiscal Year 2007/2008 will commence Monday, June 18, 2007 and continue on Tuesday, June 19 and Wednesday, June 20, 2007, if necessary. Budgets will be heard by functional groupings according to the attached Schedule.

ENVIRONMENTAL IMPACT

BACKGROUND AND DISCUSSION

The Recommended Final Budget for Fiscal Year 2007/2008 has been prepared and distributed. The format is consistent with last year's budget format, with information being provided in two sections. Traditional narrative information includes information related to department goals, objectives and performance indicators as well as interesting facts, summaries and any significant adjustments. The detailed financial information is presented in a separate section titled "Recommended Budget Detail Reports." Both sections are available through the internet or on CD-ROM.

Hearings will be presented by functional groups according to the attached schedule. Once discussion is completed on each functional group, staff is recommending that the Board tentatively approve the budget for the budgets included in that group, including any revisions made by the Board at these hearings. It is anticipated that hearings may be completed by Monday, June 18, 2007. However, if additional hearing time is necessary, they may be continued on Tuesday and Wednesday, June 19-20, 2007.

Supplemental Report No. 1 is also presented for consideration. Since the FY 2007/2008 Recommended Final Budget was compiled, circumstances have arisen which require modification to certain schedules and appropriations. These modifications will be presented when the affected budget is considered.

Upon conclusion of hearings by functional groups, various closeout items and other pending issues which may be brought up during the hearings by the Board or the public will be considered, including the budget for Contingencies. Upon completion of these actions, hearings will be closed.

Adoption of the FY 2007/2008 budget is scheduled for Tuesday, June 26, 2007.
