**SUBJECT:** Distribution of Asset Forfeiture Funds

### **RECOMMENDATION**

Napa Special Investigations Bureau (NSIB) Governing Board requests approval of the following distribution totalling \$140,394 from seized and forfeited funds from narcotic/drug trafficking investigations in Napa County during Fiscal Year 2006-2007 (4/5 vote required):

1.	Napa Sheriff's Department	41.5%	\$58,264
2.	Napa Police Department	23.5%	\$32,993
3.	Bureau of Narcotic Enforcement	11.0%	\$15,443
4.	St. Helena Police Department	9.0%	\$12,635
5.	Calistoga Police Department	9.0%	\$12,635
6.	Napa Probation Department	6.0%	\$8.424

## **EXECUTIVE SUMMARY**

According to California Asset Forfeiture laws, funds that have been forfeited are held in a trust account until distribution is approved by the Napa Special Investigations Bureau Governing Board. This action approves the Fiscal Year 2006-2007 distribution of Asset Forfeiture funds to various law enforcement agencies for future equipment purchases.

#### **ENVIRONMENTAL IMPACT**

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulation 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

#### BACKGROUND AND DISCUSSION

Pursuant to California Asset Forfeiture laws, funds that have been forfeited from narcotic/drug trafficking are held in a trust account until distribution. The bylaws of the Napa Special Investigations Bureau (NSIB) Governing Board determine the distribution percentages. The Fiscal Year 2006-2007 percentages were approved at the May 16, 2007 meeting. The Bureau of Narcotic Enforcement (BNE) has requested that their portion of funds (\$15,443) be retained by NSIB for expenses incurred by the Napa Special Investigation Bureau. The Sheriff's and Probation Department's funds will be deposited into trust accounts for future equipment purchases.
