SUBJECT: Amendment No. 1 for Agreement No. 180210B with Andrew Moffatt BVSC, Inc.

#### **RECOMMENDATION**

Director of Public Works requests approval of and authorization for the Chair to sign Amendment No. 1 to Agreement No. 180210B with Andrew Moffatt BVSC, Inc., doing business as Alley Cat Small Animal Hospital and California Pet Hospital, increasing the amount by \$35,000 for a new maximum of \$60,000.

#### **EXECUTIVE SUMMARY**

On December 19, 2017, the Napa County Animal Shelter entered into Agreement No. 180210B with Andrew Moffatt BVSC, Inc., doing business as Alley Cat Small Animal Hospital and California Pet Hospital, with a maximum compensation amount of \$25,000 per fiscal year. This amendment will increase the maximum compensation amount to \$60,000 to meet the increased need for routine and specialized veterinary services.

#### **ENVIRONMENTAL IMPACT**

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

## **BACKGROUND AND DISCUSSION**

The Napa County Animal Shelter and Adoption Center (NCAS) cares for approximately 3,000 animals on an annual basis. State and local regulations require NCAS to maintain a safe and healthy environment and provide basic veterinarian care for these animals. Since December 19, 2017, Andrew Moffatt BVSC, Inc., doing business as Alley Cat Small Animal Hospital and California Pet Hospital, has been the primary provider of veterinarian services for domestic animals under Agreement No. 180210B. Today's amendment increases the total annual maximum to more accurately reflect services required and provided annually. The previous maximum was based on the former contract which was solely for services at California Pet Hospital and did not reflect the centralization of services under one contract. In fiscal year 2016/17, the Animal Shelter spent a total of \$51,372 on veterinarian services.

Approval of Amendment No. 1 to Agreement No. 180210B will increase the maximum compensation amount to \$60,000 per fiscal year. All other terms of the agreement will remain the same.
