SUBJECT: Revenue Agreement with Reach Air Medical Services, LLC

RECOMMENDATION

Director of Health and Human Services requests approval of and authorization for the Chair to sign a Memorandum of Agreement with Reach Air Medical Services, LLC for a maximum of \$22,500 for the term July 1, 2018 through June 30, 2021 for reimbursement of oversight activities of Emergency Medical Services of emergency air ambulance services within Napa County.

EXECUTIVE SUMMARY

The current Memorandum of Agreement (MOA) with Reach Air Medical Services, LLC (Reach) will expire June 30, 2018. The purpose of today's requested action is to enter into a new MOU with Reach for 3 years beginning July 1, 2018.

REACH Air Medical Services is scheduled to move an existing airship into Napa County in June 2018. The service was previously provided regionally by airships located in Santa Rosa, Lakeport, and Concord. The response and transport of critical trauma patients by REACH Air Medical Services is a critical service provided to the residents and visitors to Napa County. REACH will continue to provide their services regionally and will service many counties in the North and East Bay. REACH Air Medical Services, transported a total of 19 patients in 2017 from the pre-hospital setting, accounting for 100% of air ambulance transports occurring in the 9-1-1 system in Napa County.

this organization. However, this agreement will allow Napa County residents to receive needed air medical services and meets EMS policy that requires an

agreement to be in place.

requested budget. This agreement expires June 30, 2021 and subsequent

fiscal year appropriations will be budgeted accordingly.

Consequences if not approved: If this action is not approved, the County will not have an agreement for

air medical service to meet the needs of Napa County residents.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

REACH Air Medical Services (REACH) provides air ambulance services throughout Northern California. Napa County EMS Agency Policy #4006 requires the EMS Agency to authorize EMS aircraft operations within Napa County. The authorization is required to have written agreements between the EMS Agency and EMS aircraft provider.

The current Memorandum of Agreement (MOA) with REACH will expire June 30, 2018. The new MOA will:

- increase Air Ambulance oversight fees from \$1,500/annually to \$7,500/annually for a total of \$22,500 during the term of this agreement. The fee increase will help reimburse the Emergency Medical Services Agency (EMS) for direct clinical and operational oversight costs associated with the air ambulance provider; and
- add additional language regarding REACH's obligations to perform criminal background checks on all of its
 officers, agents, employees, interns, and volunteers. REACH uses both pilots and Registered Nurses on
 their airships. Unlike Emergency Medical Technicians and paramedics, these personnel do not have
 certifications directly overseen by EMS.
