## RECOMMENDATION

Chief Probation Officer requests approval of and authorization for the Chair to sign the an agreement with Puertas Abiertas to receive Community Recidivism Reduction Grant funding for the term of March 15, 2015 through June 30, 2016 in the amount of \$10,000 for services through the LEGACY Youth program.

### EXECUTIVE SUMMARY

Under provisions of the Budget Act of 2014, Napa County received \$50,000 in Community Recidivism Reduction grant funding to allocate to nongovernmental agencies providing recidivism and crime reduction services. The County's Community Corrections Partnership conducted a competitive request for proposals and on May 19, 2015 the Board of Supervisors approved \$40,000 in funding for various community providers. Today staff is recommending the Board of Supervisors authorize the Chair to enter into the final grant agreement for this funding with Puertas Abiertas to implement programming aimed at reducing recidivism.

Discretionary Justification:	The grant funding will be used to implement programming aimed at reducing

	recidivism which should benefit the community through a lower number of arrests and bookings into the jail and an improved quality of life.

Future fiscal impact:	Funding may be used through June 30, 2016 and will be budgeted accordingly.
Consequences if not approved:	The County is not required to allocate the Community Recidivism Reduction grants, but if it does not the money will revert to the Board of State and Community Corrections and the community will have lost the opportunity for beneficial programming.

### ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

### BACKGROUND AND DISCUSSION

The Budget Act of 2014 allocated \$8 million to the Board of State and Community Corrections (BSCC) for the Community Recidivism Reduction Grant program. Counties are eligible to receive funds if the Board of Supervisors, in collaboration with the county's Community Corrections Partnership, agrees to develop a competitive grant program intended to fund community recidivism and crime reduction services.

On September 9, 2014, the Board of Supervisors authorized the Chair to sign a letter of interest to the BSCC notifying them of the County's intent to participate and directed the County's Community Corrections Partnership (CCP) to develop a competitive grant program that met the guidelines established by the BSCC. The County of Napa has received \$50,000 to distribute to nongovernmental entities with a maximum award of \$10,000 to each entity.

The CCP issued two competitive Request for Proposals between December 2014 and March 2015 to solicit responses from entities that would provide evidence-based programs and training to meet the goals of the County's 2011 Public Safety Realignment Plan and the authorizing legislation. On May 19, 2015, the Board of Supervisors approved agreements totaling \$40,000 in funding with four agencies: The Boys & Girls Clubs of Napa Valley, On the Move, Success Through Education Program (STEP), and B.I. Incorporated.

Today's action will authorize the Chair to sign the fifth and final agreement for the Community Recidivism Reduction Grant funding in the amount of \$10,000 with Puertas Abiertas for the term of March 15, 2015 to June 30, 2016 to support their LEGACY Youth Program. The LEGACY program engages gang-involved or gang-associated high school students and provides a positive, healthy, safe and challenging educational space for these at-risk youth. The funding will be used specifically to for supplementing the programs three annual field trips: to various colleges and universities throughout California, the Museum of Tolerance, and Homeboy Industries in Los Angeles.
