SUBJECT: Resolution temporarily closing a portion of Silverado Trail

RECOMMENDATION

Director of Public Works requests adoption of a resolution temporarily closing a portion of Silverado Trail from Oakville Crossroad to Oak Knoll Avenue in Napa from 7:00 A.M. to 10:00 A.M. on Sunday, July 12, 2015, for the Napa Valley Inline Marathon and Half Marathon skating event.

EXECUTIVE SUMMARY

The organizers of the Napa Valley Inline Marathon and Half Marathon have requested a temporary closure of Silverado Trail from Oakville Crossroad to Oak Knoll Avenue in Napa from 7:00 A.M. to 10:00 A.M. on Sunday, July 12, 2015, in order to hold this event.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: Approval of the project is a ministerial action which is exempt from CEQA (14 CCR 15268; Friends of Sierra Madre v. City of Sierra Madre (2001) 25 Cal. 4th 165).

BACKGROUND AND DISCUSSION

The California Outdoor Rollerskating Association is promoting the Napa Valley Inline Marathon and Half Marathon event on Sunday, July 12, 2015, from 7 A.M. to 10 A.M. Participants will skate along a 6.55 mile closed portion of Silverado Trail between Oakville Crossroad and Oak Knoll Avenue in Napa. Two laps are equal to 26.2 miles. Event parking will be located at Yountville Park, the same location of the after race picnic. Participants can park there and skate over to the start line.

This event is estimated to attract 200 skaters and 100 spectators. The organizers have contracted with the CHP for traffic control, and a certificate of insurance naming the County of Napa as additional insured is on file. CHP will make every effort to escort residents to their property during the event, but minor delays could occur dependent upon the number of skaters on the road at the time to make it as safe as possible for everyone.

The permit will be issued upon compliance with all applicable requirements based on the ordinance.

The following conditions are being required by Public Works to ensure adequate notification to the public and to provide a safe environment:

- a. All traffic control devices and personnel be in conformance with Caltrans' Traffic Manual.
- b. All properties having access to the portion of Silverado Trail being closed shall be notified a minimum of two (2) weeks prior to the event and access shall be provided to them during the event.
- c. Access shall be provided for emergency vehicles at all times.
- d. The California Outdoor Rollerskating Association shall contract with the CHP for traffic control services during the event.
- e. A certificate of insurance in the amount of \$1,000,000 shall be provided to the County naming the County of Napa as additional insured.
- f. All costs of clean up and repairs to County facilities damaged as a result of this event shall be borne by The California Outdoor Rollerskating Association.

- Third Annual Tour DaVita ORCA Short Track, June 14 (Bel Aire to Silverado Trail and back) no closures
- Zooma Napa Valley 1/2 Marathon and 10K, June 20 (Dry Creek, Orchard and Solano) -- no closures

The following special events are scheduled in the six weeks following this event, with locations/road closures noted:

- Napa Sonoma Wine Country Half Marathon, July 19 (Duhig Road) -- closure
- Tour of Napa Valley, August 16 (Silverado Trail, Deer Park to Napa; Lake Berryessa, Angwin, Deer Park, Mt. Veeder, Dry Creek) -- no closures
