SUBJECT: Renewal Agreement with Planned Parenthood-Shasta Diablo

RECOMMENDATION

Director of Health and Human Services requests approval of and authorization for the Chair to sign the renewal of Agreement No. 6480 with Planned Parenthood-Shasta Diablo, Inc., for a maximum of \$47,162 for the term July 1, 2006 through June 30, 2007 to provide HIV education and prevention services.

EXECUTIVE SUMMARY

Approval of the requested action will enable Planned Parenthood to provide HIV education and prevention services to reduce the number of new HIV infections in Napa County, focusing on priority populations and the reduction of racial and ethnic disparities in obtaining testing and treatment services.

ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

BACKGROUND AND DISCUSSION

Approval of this agreement will enable Planned Parenthood to receive Public Health Education and Prevention funds and Alcohol and Drug Substance Abuse Prevention and Treatment funds to provide HIV education, prevention and testing services to substance abusers in Napa County. Targeted prevention activities will be performed at homeless shelters and day programs, parks, bars, motels, tattoo and piercing sites, jails, courts, and other community sites, and at drug treatment programs with the intent of reducing harm and educating clients about the HIV risks associated with drug abuse. Culturally appropriate materials will be distributed. Clients will be referred to the Public Health Division if an HIV test is desired. Planned Parenthood will offer pre- and post-test counseling. In addition to health education activities, Planned Parenthood will complete an assessment of the prevention needs of the community.

Planned Parenthood-Shasta Diablo is not a health care provider for purposes of HIPAA. This position was taken because there is no use or disclosure of protected health information by or to the vendor under this agreement. Therefore, a Business Associate agreement is not required.
