RECOMMENDATION

Director of Health and Human services requests approval of and authorization for the Chair to sign the following agreements to provide services in the Mental Health Outpatient Managed Care Program:

1. Agreement with Rocio Beatriz Cuddy, LCSW, for a maximum of \$10,000 for the term July 1, 2005 through June 30, 2006;
2. Agreements for a maximum of \$5,000 each for the term July 1, 2005 through June 30, 2006:
 - a. Agreement with Ana Gonzalez-Hammaker, LCSW;
 - b. Agreement with Matthew S. Smith, MFT; and
 - c. Agreement with Esther Trevino, MFT.
3. Business Associate Agreements setting forth the terms and conditions of the Health Insurance Accountability and Portability Act of 1996 (HIPAA) Privacy Rule:
 - a. Rocio Beatriz Cuddy, LCSW;
 - b. Ana Gonzalez-Hammaker, LCSW;
 - c. Matthew S. Smith, MFT; and
 - d. Esther Trevino, MFT.

The contractors provide outpatient mental health services to clients of the Mental Health Outpatient Managed Care program.

BACKGROUND AND DISCUSSION

On April 1, 1998, HHSA implemented the outpatient phase of the Mental Health Managed Care Program. The program is governed by the terms of Agreement No. 4028 with the State Department of Mental Health, regulations promulgated by the federal Medicaid and California Medi-Cal programs, and by a provider operations manual developed by HHSA staff and reviewed by County Counsel. HHSA is able to bill Medi-Cal for services performed by providers and receives approximately 50% federal reimbursement for those services. Remaining costs are funded by a state managed care allocation.

The network of providers includes Psychiatrists, Psychologists, Marriage and Family Therapists (MFT's), Licensed Clinical Social Workers (LCSW's) and Masters-prepared Psychiatric Nurses. Currently the managed care program has approximately 250-300 clients whom the providers treat on a regular basis. The program requires county contracts (defined as subcontracts in the state agreement) with individual providers in the program.

This item also includes Business Associate Agreements setting forth the Health Insurance Accountability and Portability Act of 1996 (HIPAA) regulations to which the contractors are subject. These agreements provides the County with assurances that the contractors will comply with any and all HIPAA requirements.
