### **RECOMMENDATION**

Chief Information Officer requests approval of and authorization for the Purchasing Agent to issue purchase orders for annual Peoplesoft software maintenance fees from Oracle USA, Inc. of Palatine, Illinois, for a total of \$274,003 for the term July 1, 2007 through June 30, 2008.

### **EXECUTIVE SUMMARY**

Oracle's (formerly PeopleSoft) Financial and Human Resource applications are currently used throughout the County to provide automated financial and human resource operations. Software maintenance for these applications is required to ensure proper performance of this suite of applications and take advantage of new functionality added to the applications. The purchase of annual software maintenance totals \$274,003 through June 30, 2008, and has traditionally been purchased via a purchase order based on the underlying Software End User License and Services Agreement No 3730 for the software itself.

### **ENVIRONMENTAL IMPACT**

### **BACKGROUND AND DISCUSSION**

Oracle's (formerly PeopleSoft) Financial and Human Resource applications are currently used throughout the County to provide automated financial and human resource operations. Software maintenance for these applications is required to ensure proper performance of this suite of applications and take advantage of new functionality added to the applications. Items 1 through 7 below, which include Internet access, are required components that work in conjunction with one another to provide a comprehensive system.

Costs for Oracle software maintenance and telephone support for Fiscal Year 2007-2008 total \$274,003 and are detailed below:

1. PeopleSoft Financials at \$115,794
2. PeopleSoft Human Resources at \$62,547
3. PeopleSoft e-Applications at \$19,436
4. PeopleSoft EEL (Extended Enterprise) at \$14,433
5. PeopleSoft HRMS Portal Pack at \$2,992
6. PeopleSoft Merant - Net Express at \$4,583
7. PeopleSoft Projects plus at \$54,218

According to the underlying Software End User License and Services Agreement (Agreement No. 3730), the yearly maintenance fees will be renewed annually at the rate in effect at the time of renewal. The fees are included in the budget and are slightly lower than those paid in Fiscal Year 2006/2007.
