The Board of Supervisors completed public hearings for the 2007-2008 budget on June 18, 2007. This board item has been prepared by the Auditor-Controller's Office based on the Board's actions taken during the public hearings and is presented as the basis for the adoption of the final budget resolution.

The proposed appropriation and revenue figures represent the final "bottom line" totals for the All Funds budget and the Internal Service Funds budgets.
