# ENVIRONMENTAL IMPACT

#### BACKGROUND AND DISCUSSION

Due to term expirations, there are currently five openings on the Napa County Child Care Planning Council. The County Executive Office has advertised for the vacancies and received applications for each of the categories.

The Napa County Child Care Planning Council was created by resolution of the Board of Supervisors on February 10, 1998 to consist of twenty members. Ten (10) members are appointed by the Board of Supervisors and ten (10) are appointed by the Napa County Superintendent of Schools. The compositions must include 20% consumers, 20% child care providers, 20% public agency representatives, 20% community representatives, and 20% at-large members. The purpose of the Council is to assess and prioritize the community's child care and development needs.

The Napa County Child Care Planning Council has reviewed all applications and provided their recommendations for appointments to the Board of Supervisors. Also provided as an attachment for reference is a full recommendation list for both the Board of Supervisors and County Superintendent of Schools.
