SUBJECT:	Amendment No. 1 to Agreement with Delta Dental

## RECOMMENDATION

Human Resources Director requests approval of and authorization for the Chair to sign Amendment No. 1 to Agreement No. 6485 with Delta Dental of California decreasing the administration charge from 8.9% to 8.3% for the term July 1, 2006 through December 31, 2008 for a self-insured employee dental plan.

### EXECUTIVE SUMMARY

The County of Napa contracts with Delta Dental to provide discounted fees for dental procedures as well as processing and reviewing claims, mailing explanation of benefit information to members and providing customer service to County employees. After completing a review of the County's dental experience Delta Dental determined that the current administration charge will decrease from 8.9% to 8.3% for the term July 1, 2006 through December 31, 2008. The decreased administration charge represents an estimated annual savings of \$8,700 for Fiscal Year 2006/2007.

### **ENVIRONMENTAL IMPACT**

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

#### BACKGROUND AND DISCUSSION

Napa County contracts with Delta Dental to provide discounted contract fees for dental procedures ranging from preventive services such as cleaning to oral surgery such as extractions for its employees and eligible dependents.

The County is currently compensating Delta Dental 8.9% of total paid claims on a monthly basis for its administration of the dental plan. Delta administration includes processing and reviewing claims, mailing explanation of benefit information to members and customer service via telephone and web access. After completing a review of the County's dental experience Delta determined that the current administration charge will decrease from 8.9% to 8.3% for the contract term July 1, 2006 through December 31, 2008. The decreased administration charge represents an estimated savings of \$8,700 for Fiscal Year 2006/2007.
