**SUBJECT:** Renewal Agreement with Volunteer Center of Napa Valley, Inc.

#### RECOMMENDATION

Director of Health and Human Services requests approval of and authorization for the Chair to sign the renewal of Agreement No. 2242 with Volunteer Center of Napa Valley, Inc., for a maximum of \$19,250 for the term July 1, 2005 through June 30, 2006 to provide Child Abuse Prevention and Education Services.

#### **EXECUTIVE SUMMARY**

This agreement provides child abuse/assault prevention education to elementary school children, their parents and teachers throughout the County's school districts.

## **ENVIRONMENTAL IMPACT**

There is no Environmental Impact for this item.

### BACKGROUND AND DISCUSSION

The Volunteer Center's Child Abuse Assault Prevention Program (CAPP) has provided abuse prevention workshops in Napa County since 1984. The CAPP program uses a national abuse/violence prevention model in providing educational English and Spanish workshops in Napa County elementary schools. This contract will fund 60 workshops for approximately 1,200 students. The CAPP program seeks additional funding from other resources in order to provide additional workshops to children.

By direction of the Board of Supervisors, the Mental Health Board is responsible for receiving and approving applications for the use of Children's Trust Fund monies on an annual basis. The Children's Trust Fund receives revenue from birth certificate fees and property tax donations specifically given to the Children's Trust Fund. The funding is earmarked for the local Child Abuse Prevention Council and for discretionary use for children's programs in Napa County. Several Mental Health Board subcommittees consider the requests for funding and report their recommendations to the full Mental Health Board. On April 11, 2005, the Mental Health Board reviewed and approved the application of the Volunteer Center to continue provision of these services.

The Volunteer Center is not a health care provider for purposes of HIPAA. This position was taken because there is no use or disclosure of protected health information by or to the vendor under this agreement.
