#### BACKGROUND AND DISCUSSION

Pursuant to the Napa County Travel policy, Part I - Section 43, if an elected official requests out-of-state travel and time restraints do not allow for prior Board of Supervisors approval to be obtained in a timely manner, the Chair or Vice-Chair of the Board of Supervisors may authorize the County Executive Officer and/or members of the Board of Supervisors' out-of-state travel, subject to ratification at the next Board of Supervisors meeting.

Supervisor Diane Dillon was invited to appear as a witness at the Subcommittee on Indian and Alaska Native Affairs' Oversight Hearing on the "Authorization, standards, and procedures for whether, how and when Indian tribes should be newly recognized by the federal government" on Wednesday, June 27, 2012. Supervisor Dillon traveled to Washington, D.C., from June 26 to June 30, 2012, to attend the Oversight Hearing of the Subcommittee on Indian and Alaska Native Affairs. Since there was insufficient time to obtain Board authorization for this request, ratification is requested for Supervisor Dillon's out-of-state travel.
