SUBJECT: Lake Berryessa Parking Ordinance

RECOMMENDATION

First reading and intention to adopt an ordinance of the Board of Supervisors of the County of Napa, State of California amending Title 10 (Vehicles and Traffic) of Chapter 10.16 (Parking at Lake Berryessa) and Sections 10.16.010 (Definitions) and 10.16.030 (Overnight Parking Unlawful Penalty) and adding a new Section 10.16.025 (Failure to Obey Parking Signs or Markings-Penalty) and Section 10.16.045 (Parking Without a Properly Displayed Permit Unlawful - Penalty).

EXECUTIVE SUMMARY

The Sheriff's Department requests that County Code sections related to Title 10 (Vehicles and Traffic) of Chapter 10.16 (Parking at Lake Berryessa) and Chapter 10.16.030 (Overnight Parking Unlawful - Penalty) be amended to reflect a change in the title of Chapter 10.16, as well as, revised and additional definitions in Section 10.16.010 and an addition to language contained in Section 10.16.030 (Overnight Parking Unlawful - Penalty).

Further, staff requests that two new sections be added to the Code, Section 10.16.025 (Failure to Obey Parking Signs or Markings-Penalty) and Section 10.16.045 (Parking Without a Properly Displayed Permit Unlawful - Penalty).

ENVIRONMENTAL IMPACT

BACKGROUND AND DISCUSSION

From time to time portions of the County Code are amended to better reflect the needs of the County, as well as, address situations and scenarios as they arise. This ordinance intends to do just that. First, the title of Chapter 10.16 will be amended to "PARKING AT LAKE BERRYESSA," and eliminate additional and unnecessary language contained therein. Because visitors to the Lake have at times left vehicles and boat trailers for extended periods of time, the Sheriff and the Bureau of Reclamation have suggested these ordinance changes to help discourage this from happening in the future. Section 10.16.010 (Definitions) of Chapter 10.16 is amended to revise the definition of "Parking lot," and adds a new term and definition for "Valid Parking Permit." Section 10.16.030 (Overnight parking unlawful - Penalty) of Chapter 10.16 is amended to specifically address the parking lot at Capell Cove. Finally, two new sections are added--Section 10.16.025 (Failure to Obey Parking Signs or Markings Unlawful-Penalty) is added making it unlawful for any person to disobey parking signs or markings, and Section 10.16.045 (Parking without a properly displayed permit unlawful - Penalty) is added making it unlawful for any person to park their motor vehicle or detached trailer in a parking lot where a permit is required.
