SUBJECT: Oracle USA, Inc. Software Maintenance Renewal

RECOMMENDATION

Chief Information Officer requests a waiver of competitive bidding requirements and sole source award for the purchase of annual software maintenance from Oracle USA, Inc. of Palatine, Illinois, for the total of \$276,333 pursuant to County Ordinance Code 2.36.090.

EXECUTIVE SUMMARY

Oracle's (formerly PeopleSoft) Financial and Human Resource applications are currently used throughout the County to provide automated financial and human resource operations. Software maintenance for these applications is required to ensure proper performance of this suite of applications. The purchase of annual software maintenance totals \$276,333 through June 30, 2007. Oracle software applications are proprietary; and therefore it is not feasible to solicit competitive quotes for the required software maintenance. When it is not feasible to solicit competitive quotations for the purchase of individual items in excess of \$10,000, County Code requires Board approval for a waiver of competitive bidding requirements and approval of a sole source award.

BACKGROUND AND DISCUSSION

Oracle's (formerly PeopleSoft) Financial and Human Resource applications are currently used throughout the County to provide automated financial and human resource operations. Software maintenance for these applications is required to ensure proper performance of this suite of applications. Items 1 through 7 below, which include Internet access, are required components that work in conjunction with one another to provide a comprehensive system.

Costs for Oracle software maintenance and telephone support for Fiscal Year 2006-2007 total \$276,333 and are detailed below:

- 1. PeopleSoft Financials at \$116,778
- 2. PeopleSoft Human Resources at \$63,079
- 3. PeopleSoft e-Applications at \$19,601
- 4. PeopleSoft EEL (Extended Enterprise) at \$14,556
- 5. PeopleSoft HRMS Portal Pack at \$3,017
- 6. PeopleSoft Merant Net Express at \$4,622
- 7. PeopleSoft Projects plus at \$54,680

These software applications are proprietary, and therefore it is not feasible to solicit competitive quotes for the required software maintenance. When it is not feasible to solicit competitive quotations for the purchase of individual items in excess of \$10,000, County Code, Section 2.36.090 requires Board approval for a waiver of competitive bidding requirements and approval of a sole source award.
