SUBJECT: Amendments to 2020 State Legislative & Regulatory Platform

RECOMMENDATION

County Executive Officer requests adoption of COVID-19 related amendments to the 2020 State Legislative Platform.

EXECUTIVE SUMMARY

COVID-19 has dramatically changed the course of legislative affairs, including changing completely the legislative schedules, and creating extremely short deadlines for the public, including the County of Napa, to engage with the legislature on measures moving through the legislative process. Given this unprecedented time, staff is recommending amending the State Legislative Platform to allow more flexibility to the Legislative Subcommittee to take action on bills that are not clearly stipulated in the Platform, with approval by the CEO and County Counsel, and when there is no opportunity for the Board of Supervisors to take action because of deadlines. Staff is also recommending amending the platform to add a section in Priority 1 related to COVID-19.

BACKGROUND AND DISCUSSION

Since March 2020, the State and Napa County have been responding to a worldwide pandemic caused by the novel coronavirus, COVID-19, which has dramatically impacted business as usual in virtually all aspects of life. The response, which includes shelter at home orders that continue to be in effect, changed the course of legislative affairs, including changing completely the legislative schedules, and creating extremely short deadlines for the public, including the County of Napa, to engage with the legislature on measures moving through the legislative process.

The State legislature plans to return to finish the session on July 27, leaving approximately one month to finish its business before the August 31 deadline. It is anticipated that work will need to occur 7 days per week in order to meet the deadline.

Given this unprecedented time, staff is recommending amending the State Legislative Platform to allow more flexibility to the Legislative Subcommittee to take action on bills that are not clearly stipulated in the Platform, with approval by the CEO and County Counsel, and when there is no opportunity for the Board of Supervisors to take action because of deadlines. Staff is also recommending amending the platform to add a section in Priority 1 related to COVID-19.
