The California Area Agencies on Aging (AAOA) were established by the 1973 amendments to the Older Americans Act (OAA) of 1965. The AAOA is a California Nonprofit Public Benefit Corporation organized exclusively for charitable purposes as specified in Section 501(c)(3) of the Internal Revenue Code and is formed specifically to support the planning, delivery, monitoring and administration of programs and services to meet the needs and serve the interests of the elder residents of Napa and Solano Counties.

The AAOANS consists of 16 Directors: one member from each Supervisorial District in Napa County, one member from each Supervisorial District in Solano County and three additional members from each County as elected by the AAOANS.

By taking this action today the Area Agency on Aging Serving Napa and Solano counties will have a complete board of directors.
