SUBJECT:	Approval of Amendment to Agreement No. AUD5820 with Costa Engineers

## RECOMMENDATION

Director of Public Works requests approval of and authorization for the Chair to sign Amendment No. 1 to Agreement No. 6667 (formerly No. AUD-5820) with Costa Engineers Inc. increasing the amount by \$11,415 for a new maximum of \$58,235 and amending the Scope of Work to include additional professional mechanical and electrical engineering services.

## EXECUTIVE SUMMARY

Costa Engineers, Inc. was selected through a Request for Qualifications to provide professional electrical and mechanical engineering services for the lighting and HVAC renovation projects at 650 Imperial. Once access to the building was available after the New Year flood event, it was determined that extensive HVAC modifications from past remodels, which contradicted as-built drawings, necessitated additional design services.

#### ENVIRONMENTAL IMPACT

ENVIRONMENTAL DETERMINATION: The proposed action is not a project as defined by 14 California Code of Regulations 15378 (State CEQA Guidelines) and therefore CEQA is not applicable.

#### BACKGROUND AND DISCUSSION

Costa Engineers, Inc. was selected through a Request for Qualifications process to provide professional electrical and mechanical engineering services for the lighting and HVAC renovation projects at 650 Imperial. Once access to the building was available after the New Year flood event, it was determined that extensive HVAC modifications from past remodels, which contradicted as-built drawings, necessitated additional design services. These additional services included the location, measurement and mapping of interior partitions as well as documentation of duct modifications made to the buildings system since its original construction in 1981. The consultant will also be providing oversight support during construction. These services are expected to result in more efficient energy utilization in the building.
