SUBJECT: Request to Approve Budget Transfer Related to the Golden State Finance Authority Grant

# **RECOMMENDATION**

Interim Director of Health and Human Services requests approval of Budget Transfer No. HHS001 increasing appropriations in the Housing and Homeless Division (20008-01) by \$389,854 offset by revenue from the Rural County Representatives of California through the Golden State Finance Authority previously accepted by the Board of Supervisors on May 8th, 2018 in order to provide financial assistance for cost incurred related to securing or maintaining safe and stable housing to individuals and families impacted by the 2017 Napa Fire Complex. (4/5 vote required).

# **EXECUTIVE SUMMARY**

Interim Director of Health and Human Services requests approval of Budget Transfer No. HHS001 increasing appropriations in the Housing and Homeless Division (20008-01) by \$389,854 offset by revenue from the Rural County Representatives of California through the Golden State Finance Authority. This grant was already authorized and accepted by the Board of Supervisors on May 8th, 2018. The requested budget transfer will establish the budget authority necessary to deposit the funds and distribute the grant to members of the community.

#### FISCAL IMPACT

What is the revenue source? Golden State Finance Authority grant funds totaling \$389,854.

Future fiscal impact: This is a two-year agreement with all expenses fully covered by the Golden

State Finance Authority grant funds. The term of the agreement is May 2018 to April 2020. The grant funds are expected to be fully disbursed in Fiscal Year

2018-2019.

Consequences if not approved: If this budget transfer is not approved, Napa County Health and Human

Services will be unable to deposit the funds and disburse the awards to

members of the community.

## BACKGROUND AND DISCUSSION

Budget Transfer No. HHS001 increases appropriations in the Homeless and Housing Division (20008-01) community grants account line (54805) totaling \$378,500 and the admin account line (52100) totaling \$11,354 in order to establish the budget authority to purchase rewards cards for disbursement of grant awards to members of the community and the cost of administration of the grant process, offset by an increase in the other grants revenue line (47150).
