SUBJECT: Teeter Plan, Tax Rates, and the 2006-2007 Appropriation Limit

RECOMMENDATION

Auditor-Controller requests adoption of the following three resolutions:

1. Resolution authorizing the implementation of the Teeter Plan as follows:
 - a. Authorizing the continuance, for the purposes of the Teeter Plan, to be governed by Revenue and Taxation Code Section 4703.2 for Fiscal Year 2006-2007;
 - b. Authorizing the issuance of a promissory note to fund payment of the Fiscal Year 2005-2006 delinquent secured taxes; and
 - c. Authorizing the Chair and Clerk of the Board to sign the note;
2. Resolution adopting the tax rates for the Fiscal Year 2006-2007 Secured Tax Roll; and
3. Resolution establishing the Fiscal Year 2006-2007 appropriation limit and estimated revenue subject to the limit for the County of Napa as required by Article XIII-B of the California Constitution.

EXECUTIVE SUMMARY

This agenda item details the necessary steps that need to be taken by the County to continue participating in the Teeter Plan, establish the secured tax rates for the 2006-2007 fiscal year, and establish the County's appropriation limit for the 2006-2007 fiscal year.
