#### BACKGROUND AND DISCUSSION

Napa County is responsible for delivering the Community Emergency Response Team (CERT) for the Napa Operational Area. Our Emergency Response plan identifies organized and trained citizens as part of our emergency response. Currently the County offers multiple training classes throughout the calendar year. These classes are offered from American Canyon to Calistoga with the main component being offered in Napa City. The CERT instructors who teach the classes are certified instructors through the FEMA training program.

The County has entered into Professional Service Agreements with these instructors. These Agreements have ended their term and need to be renewed.

The County intends to continue the CERT program indefinitely into the future.
