RECOMMENDATION

County Executive Officer and Risk and Emergency Services Manager request approval of and authorization for the Chair to sign an agreement with Degenkolb Engineers for a maximum of \$63,000, extending the term through June 30, 2018 with no other changes to the terms and conditions to provide structural engineering services related to the Historic Courthouse damaged in the August 24, 2014 earthquake.

EXECUTIVE SUMMARY

Degenkolb Engineers has been providing structural engineering services in relation to the damage caused by the 2014 South Napa Earthquake to the Historic Courthouse. The repair and restoration project is currently in design under County leadership with oversight from Insurance. AECOM (formerly URS) is providing Program Management under contract with the County. The consultant team, including Historic Architect, Design Architect, Structural Engineer and MEP Engineer, is contracted under AECOM.

The County has requested Contractor to leverage their experience, relationships and expertise to supplement the County staff in two areas: (1) working jointly with Public Works to oversee AECOM, and (2) working with the County and Insurance consultant teams to facilitate robust and timely resolution of key issues within the design process. The intent of this scope is to reduce the risk of future cost and schedule escalation.

The consultant team, including Historic Architect, Design Architect, Structural Engineer and MEP Engineer, is contracted under AECOM.

The County has requested Degenkolb Engineers to leverage their experience, relationships and expertise to supplement the County staff in two areas: (1) working jointly with Public Works to oversee AECOM, and (2) working with the County and Insurance consultant teams to facilitate robust and timely resolution of key issues within the design process. The intent of this scope is to reduce the risk of future cost and schedule escalation.
